Warning shall also be given to said inhabitants to meet on Wednesday, May 25, 2016, at Freedom Hall, Main Street, Cotuit, at seven-thirty o'clock PM, when action will be taken on the following articles:

Article 1: To see if the District will vote to accept the reports of the officers and committees of the District as printed.

The Prudential Committee recommends this Article.

Article 2: To see if the District will vote to set the annual salaries of the elected officials as follows: Prudential Committee Members, Members of the Board of Fire Commissioners and Members of the Board of Water Commissioners: \$1,250.00 each; Moderator: \$250.00 and Town Collector: \$1,000.00.

Article 3: To see if the District will vote to raise and appropriate or transfer and appropriate the sum of \$30,000.00 to establish the reserve fund as provided under Section 5C, Chapter 40 of the General Laws.

\$26,000.00 for the Water Department for service connections

\$301,593.00 for labor and salaries of the Water Department; and

\$76,300.00 for maintenance;

\$140,350.00 for operations; and

\$52,000.00 for miscellaneous expenses

for a total appropriation of \$596,243.00 and that the receipts and revenues of the Water Department be applied to these amounts.

Maintenance, \$9,450.00,

Operating expenses, \$5,110.00, and

Miscellaneous, \$100.00

for a total appropriation of \$18,985.00.

<u>Article 10:</u> To see if the District will vote to raise and appropriate and/or transfer and appropriate the sum of \$5,000.00 for structural review of 56 High Street Building. The Prudential Committee recommends this Article.

<u>Article 11:</u> To see if the District will vote to raise and appropriate and/or transfer and appropriate the sum of \$25,000.00 for a new administrative office.

The Prudential Committee recommends this Article.

Article 12: To see if the District will vote to raise and appropriate and/or transfer and appropriate \$10,100.00 to maintain the street lights of the District.

Article 18: To see if the District will vote to transfer from Free Cash a sum of money to the FY 2016 Fire Department's Salary and Wages budget to pay for FY 2015 and FY 2016 payroll costs associated with the three year contract negotiated with the firefighters' union. (Requested by the Board of Fire Commissioners)

Article 19: To see if the District will vote in FY 2016 to transfer a sum of money from the remaining balance in Article#7 (Purchase Fire Truck) of the May 27, 2015 Annual District Meeting into the Stabilization Fund.

Article 20: To see the District will vote to add to Article VI, of the Cotuit Fire District's Bylaws a Section 5 which will read "The Clerk shall receive all requests for information from the public and determine whether the information requested is appropriate for release, but may seek counsel if necessary."

Article 21: To see if the District will vote to amend Article VIII, Section 4, of the Cotuit Fire District's Bylaws by deleting the word "certify" in exchange for the word "review".

Article 22: To see if the District will vote to amend Article IX, Section 1, of the Cotuit Fire District's Bylaws by deleting the word "supervise" in exchange for the words "provide management and oversight of".

Article 23: To see the District will vote to delete the current Article IX, Section 6 of Cotuit Fire District's Bylaws and replace it with "Fines and penalties will be imposed for unauthorized taking, diverting, corrupting, or defiling of the public water supply or upon an entity who injures, destroys, or interferes with the public water authority's operations, construction, or maintenance, including the unauthorized willful trespass on the water authority's land or facilities. These fines and penalties will be imposed in accord with Massachusetts Session Law Chapter 446 of the Acts of 2012 which amends the following General Law: Section 39G of Chapter 40; Section 9 of 92A ½; Section 170 Chapter 111; and inserting Chapter Section 123A in Chapter 266 and any other applicable Massachusetts State Law."

Article 24: To see if the District will vote to amend Article XI, Section 3, of the Cotuit Fire District's Bylaws by deleting the word "committees" so that the first words shall read "All boards and departments".

Article 25: To see if the District will vote to amend Article XI, Section 6, of the Cotuit Fire District's Bylaws by deleting the words in line 6 "who shall act as chairman" and that in line 8 the words "two members" shall become "two at large members of the District".

Article 26: To see if the District will vote to amend Article XI, Section 10, of the Cotuit Fire District's Bylaws by deleting the final sentence in its entirety. (Requested by the Bylaw Committee)
