Fran Parks:	We're at the final review of the annual meeting warrants.
Mr. Barry:	OK. I just came straight from court. I'm sorry. I didn't even have time to go home and grab everything.
Fran Parks:	We have one here.
Mr. Barry:	Thank you. Where are you? The beginning?
Fran Parks:	Yes we haven't We waited for you.
Mr. Barry:	I'd just like to say sorry for being late. I'm in the middle of a trial right now and I just got out of court.
Laurie Hadley:	I think we've made all of the recommendations. What we have to do is just go and make the motions, as far as I know.
Mr. Barry:	Do we want to just divide these up into threes?
Fran Parks:	Do the fact missions start with Article 5?
Speaker 5:	Yes.
Fran Parks:	You're 5 through 7. The Board of Commissioners are 8, 9 and 10.
	So, Laurie, do you want to do the bylaw ones?
Laurie Hadley:	I can. I will start off with
Fran Parks:	20.
Laurie Hadley:	And there are 3 of them?
Fran Parks:	No, 5.
Laurie Hadley:	And we'll do them all? I won't do any in the beginning.
Mr. Barry:	Do you want to do that?

Laurie Hadley:	Yes.
Fran Parks:	Do you want to do 1 through 4?
Laurie Hadley:	That's fine.
Fran Parks:	I'll do 11, 12, streetlights. Do you want to do the library?
Mr. Barry:	Sure. There are streetlights on 14.
Fran Parks:	I'll do that.
Mr. Barry:	OK.
Fran Parks:	I'll do 16.
Mr. Barry:	Do you want to do 13? That's your painting.
Fran Parks:	Yes. 12, 13 and 14. Employee benefits. Do you want to do the last two?
Mr. Barry:	Sure. That would be what, 16 and 17?
Fran Parks:	Right. That's 18, 19. I can do 17, if you want.
Mr. Barry:	What about 16? Will you do that?
Fran Parks:	Yes, I'll do that.
Laurie Hadley:	We don't have three and a half minutes.
Fran Parks:	Under 19, it says the Prudential Committee will make a recommendation at the annual meeting.
Mr. Barry:	Do we want to discuss that?
Laurie Hadley:	I want to see the land protected. I'm not sure that we should begin at this time with the way it's been.
Fran Parks:	I'll say what I said at the water commissioners meeting. The town council was asked to protect Bell Farm and they turned it down. If some dedicated volunteers hadn't raised the \$250,000 back in '92, there would have been 15 houses there. The land is a zone of contribution for water.

We'd have an easement for that. It supposedly only 4 acres, but I'm not exactly sure where the underground markers are that say, "This is where the zone of contribution stops." I think that if you put houses in there, they are also going to contribute to the nitrification of the bay. Quite honestly somebody could put a Chapter 40B in there and you could have Lord only knows how many houses. I think there are a lot of people that live in Cotuit today that drive by Bell Farm and think, "Well, that's just always been there."

- Mr. Barry: It has always been there.
- Fran Parks: It hasn't always been there.
- Mr. Barry: It was under agreement with the two houses way back when.
- Fran Parks: The bulldozers were already bulldozing it and bulldozing roads and they bulldozed down the house. I think that it may be a burden on us now but I think for the future generations, I think it's worth it.
- Laurie Hadley: I do not agree.
- Mr. Barry: My feeling on this. I don't often disagree with you, Laurie. It's a lot of money and it's something we hadn't planned for until it just popped up. I kind of see that as one of the last set of crown jewels in the village. It's just the 3 of us making a recommendation. The voters are going to do whatever they want to do. I personally would like to see it preserved. I would recommend us taking that money and spending the money.
- Laurie Hadley: Why don't you make a motion?
- Mr. Barry: I make a motion that the Prudential Committee recommend the approval of Article 19.
- Fran Parks: Second.
- Mr. Barry: You're ruining the show, come on.
- Fran Parks: Oh, sorry. Is there a second?
- Laurie Hadley: Second.
- Fran Parks: Yes. All in favor?

Laurie Hadley:	Aye.
Mr. Barry:	Aye.
Fran Parks:	Aye. Unanimous.
	Anything else to come before the committee this evening? I'll entertain a motion to adjourn.
