March 2025 had a total of 88 responses:

- 1 Hazardous Condition
- 6 Community risk reduction responses
- 4 Reassurance Program responses
- 8 Service Calls
- 6 Good Intent
- 14 Fire/CO2 Alarms
- 26% of calls overlapping incidents
 - o DC Clark stated that in the first quarter report file, it breaks down all of the EMS calls by EMS type

- YTD -6% overall quality

ADMINISTRATION

- Had an annual MA EMS inspection
- EMS Officer Gardner worked with Department of Public Health on Inspectors and received high praise for both his efforts and the efforts of the organization

TRAINING & PERSONELL

- Cotuit Fire Department participated in the countrywide Forestry Task Force Activation Drill
- Training on new thermal imaging cameras is scheduled for April 17, 2025, and April 18, 2025
 - o County will be providing their burn trailer which will be housed at the elementary school
 - o Already spoke with Prudential Committee and received approval for that location
 - Commissioner Zais asked DC Clark what happened on the trailer?
 - DC Clark answered that it is propane fed fires on a large trailer and interior walls can be moved around for mimic different interior designs
 - All self-contained. No threat to water table
- Firefighter Higgins is continuing through new employee orientation training
