Fran Parks: Okay. I have a couple of problems with the last time that you used it. One, the piano

wasn't put back where it belongs and it's extremely heavy so I had to get some people to do that for me, and there was quite a bit of damage done to the paint job that I had to do some touch up painting on. the contract extension. I believe I sent everyone copies?

Stan G.: Yes.

Fran Parks: Yes.

Laurie H.: Like I say, I've got everything there, I didn't have time to print it out.

Fran Parks: Okay. Any questions?

Laurie H.: No.

Fran Parks: Any questions or concerns?

Stan G.: None.

Fran Parks: None?

Stan G.: None on my side.

Fran Parks: Okay. I think we probably need a motion with a vote to continue with the contract.

Probably this down here.

Laurie H.: I move that we extend the contract with FAA beginning July 1st 2016 and continuing

up to December 31st 2016. At the monthly fee of \$3850 a month.

Fran Parks: Is there a 2nd?

Stan G.: 2nd.

Laurie H.: Aye.

Fran Parks: Aye. The next item on the agenda is the shared treasurer with West Barnstable, Mr.

Mostly what we went through was specific requirements to be a treasurer for a district, which actually we don't want a treasurer, we wanted a CPA or an accountant. Mike have you met

again to?

Mike: Well Joe and I, the outcome of that meeting was to set a schedule that would track along at monthly meetings and get you to your objective of getting a replacement by

the 1st of the year. We agreed for both districts to extend until you found permanent replacements and the game plan is for your August and their August meeting you will have a ... It's not really a job description because both parties aren't even sure that they're looking for a contractor or an employee. A marketing device of some sort that

defines ... That's targeted.

Their meeting's a week before yours so they'll get it on their August agenda and you'll do it on yours and hash that out. The plan is to move it further in the September meeting to be basically into the market by October [inaudible 00:08:10] get somebody in place before the end of December. It may be that you each go on your own paths, there's no guarantee but I think the consensus is that it helps both districts to market simultaneously and offer as much as 2 districts worth of business for employment rather than one. Yes, we have started working on a draft of a job description, for the position. We will meet that deadline so you'll have a draft for your meeting in August.

Fran Parks: Okay, great. We discussed the relative benefits and one that Mike left out was that we

can share the advertising costs for the position, which will be very helpful.

Mike: I do have a couple of other things that I haven't recorded anything on and I just

wanted to let you know that there's a new gentlemen who was elected to the fire board, he has asked us not to pay him. He's foregoing any salary of any amount.

Laurie H.: I was told when he passed on the salary, the public employee had to take a salary.

Fran Parks: Can we pay him a dollar?

Mike: He won't accept anything.

Fran Parks: Okay.

Mike: We tried to enroll him into the payroll program and get his social security number and

so forth, and his tax forms, and he just doesn't want to be paid. I know it's been done

by counselor Crocker-

Laurie H.: Okay, okay.

Mike: -The town side. In some cases I've had to not pay elected officials because they have,

it's a town job and an elected job-

Laurie H.: Yes I heard that.

Mike: Conflict of interest prohibits that. I don't think if I've seen that many examples of

people not getting paid. I don't think.

Male: This was for what responsibility again?

Mike: He's a fire commissioner, the elected fire commissioner that the district elected in May

has basically dis-enrolled from the payroll system, he's not going to accept any

remuneration. I know you met last week, I'm sorry, I was off Cape the day of the USDA

meeting, but it continues-

Laurie H.: You didn't miss anything.

Mike: -Well I forced it to where it got to, but there's more forms have come in. I'm working

on some more forms this week. We are setting up the wire instructions for the bank this week so that's progressing very well. The tank has, if you haven't noticed, stopped.

We've done all of the insurance renewals and have completed a pretty good,

comprehensive review of all the buildings. This building is now covered by the rest of it, the former carrier. We've confirmed all the contents and values for the properties. We picked up some duplication in some of the water properties. We've got all the

vehicles properly scheduled, the new fire truck has been delivered.

Fran Parks: Oh they've got it?

Mike: Yes. It's registered and-

Mike: The district appropriated 25,000 to repair the other truck so that's gone off to be

repaired. The old truck being gone we still only have the 2 so there's no trade in-

Fran Parks: Right, correct.

Mike: We've added the 3rd truck to the insurance schedule, which will drive up the cost of

the bill out of the 3, but the tank was supposed to come on ... The schedule we had originally seen from the contract was that we were going to put that insurance on the new tank 1 August and now they're saying maybe January. We're saving the cost of the

coverage of the tank.

Fran Parks: Yeah.

Mike: We're still insuring the other one, but it needs to come down, so that'll come off the

schedule at some point in the next year. May not be until almost year end, and the new tank won't come on until we can be sure it is working. Insurance is in really good shape. We're on budget and we also met with the medical coverage and the accident, we've made some changes there to stay within budget. I think insurance is in really good shape, better than it's ever been before.

Fran Parks: Great.

Mike: I had sent you an email about the FA, financial advisor, that the Cape Cod 5 pulled the

plug on that side of the business that they've been doing for years. First Southwest has agreed to take the district. It's a perfect fit for us. Most of the cape communities are going with First Southwest, so we shouldn't miss a beat. We'll arrange to transfer the files from Cape Cod 5 to First Southwest and their first real task will be to get the disclosure documents filed with the FCC on a timely basis come post-audit.

Fran Parks: You did mention about going to Southwest that we would be probably incurring a

charge of 5-7000 a year?

Mike: There'll be some cost that you never had to pay because of the relationship with the

bank. I've sent them up some of our background and our anticipated needs. I also just completed the Steven employers review of the districts bond rating and that was held at the Double A Plus so we're still pretty nicely thought of by the financial community. We will incur something and once we have a better sense of what that's going to be and what it is, we'll see if we can't afford to finance it within our own operating

budget. If we do need a reserve fund transfer, we'll queue you up for that.

Fran Parks: Okay.

Mike: The USDA, the First Southwest, the insurance, the tank and the salary, those are the

things that I wanted to record on here.

Stan G.: I have some questions. With respect to the insurance the truck that's being taken

offline to be refurbed, do we need to have total insurance on that, because it's not

going to be good.

Mike: It's not that much, you'd have to cancel the registration, so it'll cost us more in

registration fees than we're ever going to save in insurance. You can't cancel your

insurance on a vehicle unless you turn in your plates.

Stan G.: Right, okay.

Mike: Okay, the truck's in Middleborough I think, we've got it up there, we could take the

plates off, turn them in and then re-register it to drive it home. I think we're okay, it

won't kill us. We're budgeting for it.

Stan G.: Yes. On the USDA loan, I'm sure you're aware that we've got a \$500,000 grant instead

of a \$200,000 grant?

Mike: I very much know that. I've been working on that. I had a lot to do with that. There was

Mike: AA.

Stan G.: Before that? 4 years?

Laurie H.: I can tell you that we have had a rating before because at one point the treasurer

resigned and I was the clerk and the Prudential committee at the time wanted to see one person do both jobs. Like an idiot I said I'd do it. I was way in over my head and one of the things I had to do was a bond issue and that's when I put a bank out of business. If you listen to the young lady that called me, after I selected a bank that wasn't hers and we did have a Standard and Poor's rating at that time and I don't

remember if it was Double A or what, but it was A's.

Mike: I don't think it was very high.

Laurie H.: No.

Stan G.: What's the highest? Triple A?

Fran Parks: Triple A.

Laurie H.: Triple A, yes.

Stan G.: Okay, so we're just one notch below. Yeah, Triple A Plus.

Mike: Westfall. They will charge us to help us . I can take care of a lot of stuff

Stan G.: Should we consider putting a brief couple of lines in the Cotuit Currents with the fact

that S&P has rated us Double A Plus?

Fran Parks: Wide open. I'm also looking into possibly replacing these 300 watt bulbs that we have

up here with LED's, see if that's-

Stan G.: Yes. Do they make 300 watt LED's?

Fran Parks: I'm checking that, I have somebody checking that for me.

Stan G.: Yes, because I ... Well I don't know. If they do, go for it because they use about

between 5 and 10% of the power that these hogs do.

Fran Parks: Yes, right, that's ... Okay. High Street. Last, I don't even remember what day it was,

Friday I think. I was at the fire station, I can't see very well but I can hear extremely well and I walked into the fire station and I thought I heard some of the gravel in the

Fran Parks: They also, Mrs. Hadley very graciously allowed the people ... What was their name?

Laurie H.: McDonald.

Fran Parks: McDonald.

Laurie H.: Bob and Sharon.

Fran Parks: Bob and Sharon, to put their boat in our yard. That obviously spilled over into-

Stan G.: Parking and gravel.

Fran Parks: Parking and gravel and various other things.

Stan G.: Maybe we just ought to let them use it through the season, since you gave them the

okay? I'm just thinking it might cause them a hardship and then tell them, hey, next

year that's not possible. It's just an idea.

Fran Parks: Yes, well, we can do that but I still want to put a chain up to keep other people out. I'll

Stan G.: Are we going to have to log onto the county server to get the mail or is it automatically going to be forwarded to us somehow?

Fran Parks: That's what was happening with Go Daddy and they seem to think that's where the problem is. I thought that when we signed with the county that they would be hosting the email also, but apparently between Patricia and the folks at the county had made the decision to leave it intact with Go Daddy until the 31st of December and then transfer it over. It never got transferred over. Rick Pisano also had some problems with the email. Along with that, I've a couple other things I want to say about the open meeting law complaints. One, I'm not longer going to be responding to these complaints. I want Mr. Boudreau to do it. It's extremely time-consuming, can be frustrating at times to deal with those people in Boston and I don't want to do it anymore.

I did it because it saved the district money, rather than using the services of Mr. Boudreaux, which is probably now going to be now costing \$800 to \$1000 for his services if any more complaints come in, but I don't want to do it anymore. When Rick Barry went to renew his law license, he had to put down the open meeting law complaints filed against him. I have a Massachusetts drug license, I also have a DEA license and not to mention my physician assistant license in the state of Massachusetts and I understand that these are civil complaints and would be a civil fine, but I'm just no longer interested in putting those at risk for any problems. I'd also like that any future open meeting law complaints submitted by anyone come by snail mail. Not email, but be mailed through the post office. I'd like to have that information put on the website so that people will know we need to have it mailed.

Laurie H.: Sounds like a good idea to me. I have a comment I'd like to make too when you're finished Fran.

Fran Parks: Okay. It would prevent this problem from occurring again in the future. That's all I have to say. Ms. Hadley?

Laurie H.: A lot of these open meeting law complaints have alleged that we discuss things outside meetings, I don't need anybody to tell me how to think on any subject or how to vote on any subject. If I happen to frequently think along the same lines as another member of the committee, that's not an open meeting law violation. If you don't believe that I mean what I say about nobody's going to change my mind, I'll change it if I feel it's necessary, ask my husband.

Fran Parks: Stan, any comments?

Stan G.: Yes. Since you brought it up, in the open meeting law complaints, there's been a lot of assumptions not backed by facts. I can state also that I do not communicate with these people except for administration things, like first I said I was going to be on vacation today, I wouldn't be here, then I said, "Well I'm going to change it," because I wanted to be here. We just don't communicate outside of this Hall.

Laurie H.: Aye, and I make a motion that we accept the minutes of the 27 June, 2016 meeting.

Fran Parks: I second that.

Laurie H.: Aye.
