ANNUAL REPORT OF CLERK

ANNUAL MEETING—COTUIT FIRE DISTRICT February 11, 1963

In accordance with the foregoing notice and the bylaws of the District, the annual meeting of the Cotuit Fire District was held in Freedom Hall with over thirty voters present on Monday, February 11, 1963, at 8 o'clock P.M. and the Clerk called the meeting to order.

Article 1. Roger Scudder was unanimously chosen Moderator for one year.

Article 2. After taking the oath of office, the moderator appointed Stanley Burgess, Lawrence Bearse, Calvin Crawford as tellers who also took the oath of office.

Robert Behlman took the oath of office as a member of the Prudential Committee for three years after the meeting adjourned.

Article 3. Upon motion duly made and seconded, it was unanimously Voted: "That the District Treasurer, with the approval of the Prudential Committee, be authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1964 and to issue a note or notes therefor payable within one year and renew such note or notes as may be given for a period of less than one year in accordance with General Laws."

Article 4. Upon motion duly made and seconded, it was unanimously Voted: "That the District Treasurer, with the approval of the Prudential Committee, be authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1963 and to issue a note or notes therefor payable within one year and renew such note or notes as may be given for a period of less than one year in accordance with General Laws."

Article 5. Upon motion duly made and seconded, it was unanimously Voted: "That the District accept the reports of the officers and committees of the District as printed and that the special committee to study the needs of the fire department be continued."

- Article 6. Upon motion duly made and seconded, it was unanimously Voted: "That this article be indefinitely postponed."
- Article 7. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sum of \$1,800.00 for salaries and expenses of the financial department for the current year and that the moderator be paid \$20.00 for his services."
- Article 8. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sum of \$6,500.00 for the expenses of the fire department for the ensuing year."
- Article 9. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sum of \$250.00 for the maintenance of the Cotuit Library Association Inc."
- Article 10. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sum of \$1,500.00 for the expense of Freedom Hall for the ensuing year."
- Article 11. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sum of \$4,450.00 for the purpose of lighting the streets of the District for the ensuing year."
- Article 12. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sum of \$11,000.00 for the payment of water bonds and notes maturing the current year."
- Article 13. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sums of:

\$2,000.00 for interest on water bonds and notes \$2,500.00 for the water dept. for new services \$19,387.00 for the operating and maintenance of the water dept.

\$1,000.00 for the water dept. for extensions and that the estimated receipts and revenues of the water dept. be appropriated towards the tax levy."

Article 14. Upon motion duly made and seconded, it was unanimously Voted: "That the District authorize the Board of Water Commissioners to purchase or take by eminent domain, for the purpose of increasing the District water supply, the land formerly owned by Mary S. Crocker, located on the east side of Main Street and northeasterly of the existing water tower, consisting of two hundred acres, more or less, and borrow and appropriate the sum of twenty thousand dollars to cover the expenses incidental thereto, and an award to the owners of said land for such purchase or taking. That the Treasurer, with the authorization of the Prudential Committee and approval of the Water Commissioners, issue bonds or notes of the District therefor payable in not more than twenty years in accordance with provisions of Chapter 44 of the General Laws."

Article 15. Upon motion duly made and seconded, it was unanimously Voted: "That the District raise and appropriate the sum of \$1,500.00 to provide for the purchase of hose and equipment for the fire dept.

Article 16. After a discussion of matters of general interest, it was moved, seconded, and voted to adjourn. This Meeting:

REPORT OF THE BOARD OF WATER COMMISSIONERS

To the Citizens of the Cotuit Fire District:

Your Board of Water Commissioners submits herewith its twenty-seventh annual report for the year ending December 31, 1963.

At the annual Fire District meeting held February 11. 1963, Mr. Phillip Brackett was re-elected for a term of three years.

The Board has held monthly meetings regularly and held special meetings when necessary. Expenses have been kept at a minimum consistent with the proper operation of the department. Two water main extensions were installed. Contracts with Whitman & Howard, Engineers, and D. L. Maher Co., well builders, are in effect, in connection with our additional water supply.

One of the major problems at present is the decrease in flow of water from our original wells installed in 1936. Methods to improve the condition are under consideration. Nine new services were installed this year. We now have 509 services of which 24 are inactive.

ANNUAL REPORT OF THE PRUDENTIAL COMMITTEE

To the Citizens of the Cotuit Fire District:

Your Prudential Committee submits herewith its annual report for the year 1963.

At the annual Fire District meeting, Robert Behlman was elected a member of the Prudential Committee for a period of three years.

The Cotuit Fire District has at present a valuation of \$4,743,975.00. The Fire District tax for 1963 was \$7.00 per thousand.

During the past year Freedom Hall has been used 107 times for various civic meetings. Some of the organizations using the hall are as follows: Cotuit Athletic Association, Town Elections, Historical Society, Federated Church Youth Fellowship rehearsals and Minstrel Shows, Federated Church Auction, Couples Club Dances and the Barnstable Recreation League.

The Prudential Committee has received during the past year three written requests for new street lights.

ANNUAL REPORT OF THE BOARD OF ENGINEERS

To the citizens of the Cotuit Fire Distict:

The Board of Engineers submits herewith it's annual report for the year ending December 31, 1963.

The department has responded to 55 emergency calls during the year; 16 fires and 39 ambulance calls.

The loss by fire was estimated to be \$1,112.96 of which \$1,062.96 was covered by insurance.

The department has held 11 fire drills, 8 rescue squad drills, has had a fire school consisting of 20 hours of instruction furnished by the Massachusetts Department of Education and has held a standard first aid class, instructed by the Captain of the rescue squad. Eight members also attended a two day training session held at the Barnstable County Fire Training School. We have continued storing the equipment belonging to the Schwab Fund and have delivered and picked up; hospital beds, wheel chairs, cammode, walker and other equipment; to people in need of them during the year.

Plans are being made to present a program of replacing our two pumping engines which are 24 and 28 years old and to make repairs to the fire station. This program will be started at the 1965 District meeting. It is expected that a request will be made at that time to replace one truck.

COTUIT FIRE DISTRICT WARRANT

Annual Meeting --- February 10, 1964

To the Clerk of the Cotuit Fire District: GREETING:

You are hereby required and directed to notify and warn the inhabitants of the Town of Barnstable residing within the territory comprising the Cotuit Fire District qualified to vote in District elections and affairs, to meet in Freedom Hall, Cotuit, Monday, February 10, 1964, at 8 o'clock P.M., then and there to act upon the following articles:

Article 1. To choose a Moderator for one year.

Article 2. To elect one member of the Prudential Committee for three years, one member of the Board of Water Commissioners for three years, a Clerk, Treasurer, Chief Engineer, First Assistant Engineer, Second Assistant Engineer, Three Auditors, all for one year and to elect any other officials not mentioned.

Article 3. To see if the District will authorize the Treasurer, with the approval of the Prudential Committee, to borrow money on or after January 1, 1965, in anticipation of the revenue of the financial year beginning January 1, 1965.

Article 4. To see if the District will authorize the Treasurer, with the approval of the Prudential Committee, to borrow money on or after January 1, 1964, in anticipation of the revenue of the financial year beginning January 1, 1964.

- Article 5. To hear and act upon the reports of the officers and committees of the District.
- Article 6. To receive and act upon the accounts of all persons to whom the District may be indebted.
- Article 7. To see if the District will vote to raise and appropriate a sum not to exceed \$1900. for salaries and expenses of the financial department for the ensuing year.
- Article 8. To see if the District will vote to raise and appropriate a sum not to exceed \$6845. for the expenses of the fire department for the ensuing year.
- Article 9. To see if the District will vote to raise and appropriate a sum not to exceed \$250.00 for the maintenance of the Cotuit Library Association, Inc.
- Article 10. To see if the District will vote to raise and appropriate a sum not to exceed \$1500. for the expenses of Freedom Hall for the ensuing year.
- Article 11. To see if the District will vote to raise and appropriate a sum not to exceed \$4,600.00 for the purpose of lighting the streets of the District for the ensuing year.
- Article 12. To see if the District will vote to raise and appropriate a sum not to exceed \$10,500. for the payment of water bonds and notes maturing the current year.
- Article 13. To see if the District will vote to appropriate from the receipts and revenues of the Water Department:
 - (a) \$2,000.00 for interest on water bonds and notes
 - (b) \$4,000.00 for the water dept. for new services

- (c) \$18,339.00 for the operating and maintenance of the water dept.
- (d) \$1,000.00 for the water dept. for extensions.

Article 14. To see if the District will vote to raise and appropriate a sum not to exceed \$8,500.00 for the purpose of installing a water main in Crocker Neck Road for a distance of about twenty-two hundred feet subject to a District by-law passed on March 10, 1950.

Article 15. To transact any other business that may legally come before the meeting.

And you are hereby directed to serve this warrant by advertising same in a newspaper printed within the Town of Barnstable seven days at least before the time of said meeting.

Hereof fail not to make due return of this warrant and your doings thereon to said meeting.
